TOURNAMENT RULES

1. **This is a Mail-o-Graphic tournament.** Scores bowled in the 500/600 Doubles Tournament or the 700 Open Singles Tournament bowled on the same day are the only scores eligible for this tournament.
2. Trio teams must have **AT LEAST ONE** member in good standing with the Ann Arbor Association 700 Club, Chapter #25. **All participants must be certified members of the USBC.** Anyone not yet sanctioned must buy an affiliated membership card (**\$23.00**) or pay the participation fee (**\$5.00**) in one of the two tournaments listed in rule 1. **All fees must accompany the entry.**
3. **Multiple participation is allowed providing each team has AT LEAST ONE member in good standing with the Ann Arbor Association 700 Club, Chapter #25 and at least one player is changed from previous team.**
4. Everyone will use his or her highest yearbook average from the 2017-2018 season, from ANY certified league of 21 games or more (as recorded on bowl.com). If no last year's average, then you will use your highest yearbook average for the 2016-2017 season, from any certified league of 21 games or more (as recorded on bowl.com). If no yearbook average, then you will use your highest certified average as of December 31, 2018 of 21 games or more. All others will bowl scratch (230 scratch).
4. Team handicap will be 90% of the difference between team average and 690, based on a three-game series.
5. USBC Rule 319a-2, Ten Pin Rule and Rule 319d, Prize Winnings Reporting will **NOT** apply.
6. USBC Rule 319a-3, failure to use the correct average or make correction prior to completion of the first game of a series shall disqualify score if the submitted average is lower than correct team average. Prize winnings shall be based on the submitted average if it is higher than the correct team average.
7. USBC Rule 319e regarding re-rating will **NOT** apply.
8. All decisions of the tournament management are final unless an appeal is made in accordance with USBC rule 329.
