TOURNAMENT RULES

1. Bowlers are expected to enter this tournament with the sole purpose of entering the 700 Club Open Trio Tournament. **All participants must be certified members of the USBC.** Anyone not yet sanctioned may buy an affiliated membership card (\$23.00) or pay the participation fee (\$5.00). **All fees must accompany the entry.**
2. Bowlers will use their highest yearbook average from the 2017-2018 season, from ANY certified league of 21 games or more (as recorded on bowl.com). If no last year's average, then you will use your highest yearbook average for the 2016-2017 season, from any certified league of 21 games or more (as recorded on bowl.com). If no yearbook average, then you will use your highest certified average as of December 31, 2018 of 21 games or more. All others will bowl scratch (230 scratch).
3. Handicap will be 90% of the difference between bowler's average and 230, based on a three-game series.
4. There will be one prize for the high singles score with handicap.
5. USBC Rule 319a-2, Ten Pin Rule and Rule 319d, Prize Winnings Reporting will **NOT** apply.
6. USBC Rule 319a-3, failure to use the correct average or make correction prior to completion of the first game of a series shall disqualify score if submitted average is lower than correct average. Prize winnings shall be based on the submitted average if it is higher than the correct average.
7. USBC Rule 319e regarding re-rating will **NOT** apply.
8. All decisions of the tournament management are final unless an appeal is made in accordance with USBC rule 329.
